Subject: Clarifications for the additional information in the notes to the financial statements of quarter 3/2023 regarding the petitions inquired by the Stock Exchange of Thailand

To: Director and Manager
Stock Exchange of Thailand

As the Stock Exchange of Thailand has requested JKN Global Group Public Company Limited (the "Company") to clarify additional information in the notes to the financial statements of quarter 3/2023, the Company hereby clarifies the following facts:

On September 25, 2023, TCG Social Media Group Company Limited (Plaintiff) filed a lawsuit accusing the Company (1st Defendant) and the managing director (2nd Defendant). The plaintiff filed a lawsuit accusing that the defendants committed a criminal offense and were accused of defamation through advertising and the Computer-Related Crime Act. It is alleged that the two defendants posted defamatory messages to the plaintiff via online media regarding the plaintiff's issue of a false Miss Universe Coin, causing the plaintiff to suffer damages. The plaintiff has attached evidence of the agreement, together with the translation and complaint, and explains that the plaintiff has signed to bind with both defendants regarding the issuance of the coins. The plaintiff requests damages in the amount of THB 1,000 million. The court has scheduled a preliminary hearing on December 18, 2023. However, the Company's management is of the opinion that the Company and the 2nd Defendant have announced a message warning the public and investors, which is an honest action and for the public's interests. Therefore, it is considered that this is an exception according to the applicable laws and does not consider the defendants' actions as an offense as the plaintiff has filed a lawsuit with the court. The Company is of the opinion that the possibility of damages is still uncertain and, therefore, has not estimated the damages that may occur in the financial statements.

However, as the court has not accepted the case until the preliminary hearing is complete, it will be effective when the court orders that this case has sufficient grounds to be considered, and because the impact has not been clearly concluded, the Company has not estimated the damages that may occur in the financial statements. The Company is confident in preparing the information to be provided to the court and believes that the Company will handle the matter satisfactorily.

If there is progress, the Company will further inform everyone through the information disclosure system of the Stock Exchange of Thailand.

Please be informed accordingly.
